**CONTRACT SCHEDULE**

We/I made this proposal with full knowledge of the kind, quantity of the articles and services required, and if said proposal is accepted, will, after receiving written notice of such acceptance, enter into a contract within five [5] calendar days with good and sufficient securities for the faithful performance thereof.5

**LIQUIDATED DAMAGES**

We/I understand that time is an essential part of this proposal/contract and that upon my failure to comply the work within the stipulated completion date, we/I agree to pay equivalent to one-tenth of one percent [1/10 x 1%] of the contract sum each day of Delay in the completion of this contract, said payment to be made as liquidated damages and not by way of penalty and we/I further agree that the OWNER may automatically deduct from any amount due or become due to us/me any sum accruing for liquidated damages as herein stated.

We/I will not give money, commissions, gratuities, loans, sidelines, financial assistance, educational grants, representations, contributions (sponsor sports activities), donations (buy raffle tickets), gifts, favors, blowouts, free snacks (during site meetings) to any personnel of OWNER. We/I will report immediately to the OWNER and if there will be any attempt to ask, cajole, harass, extort or blackmail us/me for money or favor.
